Director of Schools Search Begins with Stakeholder Feedback

The Tennessee School Boards Association (TSBA), which the Clarksville-Montgomery County Board of Education selected to identify candidates for the next CMCSS Director of Schools, will be hosting feedback sessions with various stakeholder groups on Tuesday. TSBA's Deputy Executive Director Randall Bennett will facilitate conversations with the stakeholders to solicit what criteria should be considered when choosing the next Director. The criteria will be presented to the School Board in early February.

Individuals from specific stakeholder groups will be invited in for meetings throughout the day on Tuesday, Feb. 24. An open meeting for employees and community members will be held at 5 p.m. in the Ann Hunter Board Room at Central Services – Gracey Avenue.

Interviews for candidates will be held in early April, with an announcement of the selection in May. Dr. Worthington, who completes his fifth year as Director of Schools at the end of this school year, is retiring after 31 years of service to CMCSS.



2017-18 Aspiring Administrators Academy Call for Applicants

Professional Learning has announced the Aspiring Administrators Academy for the 2017-18 school year to begin this summer. An information meeting for interested individuals will be held Tuesday, Feb. 28, 2017 from 4-4:30 p.m. in the Board Room at Central Office. This meeting is open to any certified staff member interested in applying for the Aspiring Administrators Academy who would like more information on the academy, its requirements, and the

Basic requirements are as follows:

- 1. Have a master's degree or be actively working toward a master's degree that will lead toward an Instructional Leader License Beginning ILL-B.
- 2. Hold a valid Tennessee teaching certificate and plan to obtain an ILL-B.
- 3. Have a minimum of five years of work experience in a paid position as a K-12 teacher.
- 4. Have participated in a CMCSS sponsored Leadership Academy and/or Aspiring Leaders OR have equivalent experience in leadership fundamentals.
- 5. Submit a completed Candidate Application.
- 6. All applicants will participate in an interview to be scheduled following application submission.

Selection to this leadership program will be based on the applicant's ability to meet the Tennessee Instructional Standards for School Leaders as described in the Aspiring Administrators Academy Application Packet for 2017-2018. Completed applications are due by 4:30 p.m., April 3 at the Professional Development Center, 1312 Central Services South, Clarksville. All references are due the April 4 at the same office by 4:30 p.m.
