### **Director of Schools Search**

The Clarksville-Montgomery County School Board continues its search for a new Director of Schools to replace Dr. B.J. Worthington, who is retiring at the end of this school year. The School Board will review applicants' information in early May and determine which candidates it will invite for interviews. Interviews are tentatively scheduled for the week of May 15.

### **Teacher Job Fair Held at Central Services South**

The Human Resources Department held an on-site teacher job fair with 299 teacher candidates pre-registered.

Contracts were offered to 37, while many others are in process. Due to unprecedented community growth and normal turnover, CMCSS anticipates the need to hire 400 teachers for the next school year.

# **Benefits Update**

### **Frequently Asked Questions About Insurance**

### When is open enrollment?

Open enrollment for Blue Cross Medical/Dental and the Vision Service Plan is during August and September of each year. Open enrollment for Colonial Supplemental Insurance and MedFSA/DCAP is typically during November of each year. The exact dates will be communicated prior to the enrollment period.

#### When can I add an eligible dependent to my plan?

Eligible dependents may be added during open enrollments or within 30 days of a change in status (marriage, birth, adoption, loss of other coverage).

### When can I delete a dependent from my plan?

A dependent may be deleted at any time by sending a completed Delete Dependent Form (BEN-F006) to the Benefits Office. Remember, in case of divorce, your spouse is no longer considered an eligible dependent and must be removed from your plan.

### What is my deductible?

The medical deductible is \$350 per family member, with a maximum of \$875 per family. The prescription deductible is \$75 for brand name medications. You begin to meet a new deductible on January 1 of each year.

### How do I find an in-network provider?

You can find an in-network provider by going to the Blue Cross Blue Shield website (<u>http://www.bcbst.com</u>) or call the Member Services number on the back of your Blue Cross insurance card.

### Made Any Changes? Have Any Changes Coming Up Over the Summer?

If you're moving, changing your name, or doing anything that affects your personal information, be sure to let Human Resources know.

If you're adding a spouse or new baby, or making any changes to your insurance, contact the Benefits Office. Remember that changes to your insurance coverage due to a status change must be made within 30 days of the event.

If you need to update your beneficiary forms, please contact the Benefits Office.

Hospitals that are in the SELECT (S) Network include Tennova Healthcare-Clarksville (formerly Gateway), Vanderbilt, St. Thomas, St. Thomas Midtown (formerly Baptist) in Nashville, and Northcrest Medical Center in Springfield. Please remember that Centennial, Skyline, SouthernHills and Summit Medical Center are among the hospitals that ARE NOT in the Select Network and therefore will result in a much larger out of pocket cost to you.

After already implementing the following options: move selfcontained programs to schools with capacity; open enrollment for schools with capacity; add portables; and, rezone; the only remaining options would be to expand existing schools and/or construct new schools.

# **On the Job Injury Program Information**

Effective January 1, 2006, and pursuant to Tennessee Code Annotated \$50-6-106(16), CMCSS elected not to participate in the Tennessee Workers Compensation law and instead implement and administer an On-the-Job Injury ("OJI") Program. The purpose of this program is to provide uniform procedures for the reporting, medical treatment, and compensation of work related injuries or illnesses for eligible employees. The positive outcomes are results of the program change, self-administration, and aggressive return to work program.
