Background Check Information for CMCSS Staff Hired Before 2000

During the 2018 Legislative Session, a bill (Public Chapter 1006) T.C.A §49-5-413 passed and was made effective July 1, 2018, related to criminal history record check requirements for public school employees. See link to Public Chapter 1006 for specifics Public Chapter 1006. While CMCSS will follow this law, the Legislature did not provide funds for the School System, nor its employees to pay for the record check.

Criminal history record checks were only required by law beginning in 2000. At this time, CMCSS will be focusing on employees who have never been fingerprinted. Over the next several weeks, about 800 CMCSS employees who were hired before 2000 will individually receive an email, notifying them of their requirement to complete a TBI/FBI background check. A process fee will be taken from each affected employee's two (2) payroll checks in two (2) deductions, for a total of \$32.65.

Results will be forwarded to a CMCSS Human Resources Department Representative. The results are kept confidential and are not part of an employee's personnel file.

Flu Clinics for CMCSS Staff, Dependents

The Safety and Health Department is offering two Flu Clinics in October to CMCSS employees and their dependents.

Montgomery County Civic Hall-Thursday, 10/4/18, 3:30pm-6:30pm Montgomery County Civic Hall -Tuesday, 10/16/18, 3:30pm-6:30pm

Any employee who plans on receiving the flu vaccine must present a valid ID and their insurance card. Employees not covered under the BCBS insurance plan may still receive the flu vaccine for a \$15 cash only charge.

CMCSS is administering the Flucelvax Quadrivalent. It helps protect against the 4 strains of influenza (2 A strains and 2 B strains) recommended by the CDC for the current influenza season.

<u>The Quadrivalent is appropriate for ages 4 years old and up only.</u> Please visit your child's pediatrician for additional options for flu protection of kids that are 3 and younger. Common Side Effects:

- pain or redness where you got the shot
- headache
- tiredness
- muscle aches
- feeling unwell (malaise)


For all of the possible side effects of this vaccine, please visit the CDC website at www.cdc.gov.

You should not get Flucelvax Quadrivalent if you have had a severe allergic reaction to any of the ingredients in the vaccine or if you have been diagnosed in the past with Guillain–Barré. If you have questions as to whether or not you should receive the flu vaccine, due to any previous or current illness/allergy, please contact your primary care physician. The nurses administering the vaccine are not able to give medical advice.
