## **Electronic W2 and 1095-C Forms**

Starting January 2019, we will have the capability to email employees their annual tax forms (W2 and 1095-C) instead of printing them and sending them to the schools to handout. The email will require a password to open the documents. The password is the same password that you currently use when you receive your direct deposit each pay day. In order for the district to send your annual tax forms electronically, we must get the employee to sign a consent form.

Every active employee has received an email that has a web link they can click on that will take them to an online consent form. If you want to opt-in to receive your annual W2 and 1095-C forms electronically, then you sign into the online consent form with your "My Login" information and complete the form. It takes less than a minute to complete the form. For added convenience, you can also complete it using a mobile device.

If you choose not to receive your annual tax forms electronically, then you do not need to do anything. You will receive a hard copy of your annual tax forms just as you have in the past.

# **Benefits Update**

## **Important Pharmacy Information**

Beginning on Jan. 1, 2019, your prescription drug benefits will be administered by EpiphanyRx instead of Express Scripts through BlueCross BlueShield of Tennessee (BCBS of TN). The Clarksville Montgomery County Employees Insurance Trust (CMCEIT) made this change in order to provide you with long-term benefits through a respected pharmacy benefit manager that is known for clinical expertise and exceptional member services. As pharmacy costs continue to rise, the Insurance Trust has researched options that may help you and us contain and potentially experience pharmaceutical savings.

BCBS of TN will continue to be your medical carrier. Prior to Jan. 1, 2019, BCBS of TN will send you a new ID card to your home address that includes EpiphanyRx information so that you may get prescriptions.

## What you need to know:

- Retail Network Includes 70,000 pharmacies and all major pharmacy chains are included.
- Specialty pharmacy services are provided by AcariaHealth and Mail Pharmacy services are provided by HomeScript.

### What if I have remaining refills on a current prescription?

In a transition like this, EpiphanyRx will receive an "Open Refill Transfer File" (ORTF) from ExpressScripts. If the member has refills remaining they should be reflected on that file. HomeScripts (Epiphany's mail order pharmacy) will have an accounts set up and those refills will be handled by HomeScripts on/after 1/1/19.

#### What's next?

You will receive additional written communication via mail from EpiphanyRx, including a welcome letter in December. You will receive a new ID card from BCBS of TN that includes EpiphanyRx information in late December.

Ensure that you provide a copy of your new insurance card to your pharmacy on or after January 1, 2019 when obtaining a prescription. If your doctor calls in your prescriptions, you will want to provide your doctor's office with a copy of your new insurance card as well.

Note: If you are currently participating in the TrueLifeCare Diabetes Management Program, you will continue to receive your supplies from TrueLifeCare. If you do not participate in this Program, you may purchase your test supplies at a pharmacy by paying the required coinsurance payment.

## **New Blue Cross Blue Shield Dental Rates**

Blue Cross Blue Shield is requiring a rate increase on the Dental Plan effective January 1, 2019. The current dental premium has been effective since Jan. 1, 2017. Due to claims history for the past two years, a rate increase is needed. The CMCEIT continues to review the Dental Plan and will make changes, if warranted.

There will not be any changes to dental coverage and it will remain in the Preferred Network. Please be reminded that preventive dental care is paid at 100% and routine visits to your dentist can prevent problems with your oral health before they pose potentially serious problems to your overall physical health. Regular checkups are also advantageous for the early detection of underlying medical conditions.

Due to dental deductions not being payroll deducted in the summer, an additional deduction will be taken to catch up your dental premium for the 2018-2019 year. The amount of the deduction and the payroll it will be deducted on will be communicated at a future time.
