## **Benefits Update**

#### 2020 Contribution Maximum for 401(k) and 403(b) Retirement Accounts

The Internal Revenue Code limits the amount you can contribute each calendar year to 401(k) and 403(b) retirement accounts. The federal general limit for 2020 will be \$19,500. If you are age 50 or older, the general limit contribution amount may be increased by an additional contribution of \$6,500.

## **Important Dental Insurance Information**

The Clarksville Montgomery County Employees Insurance Trust is pleased to announce an increase in the Annual Maximum Benefit amount for the Blue Cross Blue Shield Dental Plan, effective January 1, 2020. The Annual Maximum Benefit will increase from \$1500 to \$2000 per member per year. This is the only change in the dental coverage and Preferred will remain the provider network for the dental plan. Due to the increased dental plan benefit and past claims history, there will be a 1.45% premium increase. The current as well as the new dental premium deductions are listed below. Please see the chart that matches your pay frequency, either monthly or bi-weekly.

Due to dental deductions not being payroll deducted in the summer, an additional deduction will be taken to catch up your dental premium for the 2019-2020 year. The amount of the deduction and the payroll it will be deducted on will be communicated at a future time.


